The Government of Nepal (GoN) has allocated TB-SWAp funds to Bahradashi Rural Municipality for Trail Bridge Program and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for Fabrication & supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.

2. The Bahradashi Rural Municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum three trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Bahradashi Rural Municipality or may visit PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np).
5. A complete set of Bidding Documents in English may be purchased from the office of Bahradashi Rural Municipality, Chakchaki, Jhapa by eligible Bidders on the submission of a written application, along with the copy of company/firm registration, business registration certificate, VAT and PAN registration certificate and tax clearance certificate of fiscal year 2074/75 and upon payment of a non-refundable fee of Nrs 1000.00 before 17.00 Hrs of 14th May, 2019 (31st Baisakh, 2076). Or  
Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 

Bid Document may be purchased from the Bahradashi Rural Municipality Office, Chakchaki, Jhapa upon payment of a non-refundable fee of **Nrs 1000.00** in cash or may deposit on office account as stated above.

Sealed or electronic bids must be submitted to the office stated below or through PPMO website [WWW.BOLPATRA.GOV.NP](http://WWW.BOLPATRA.GOV.NP). on or before 12.00 Hrs. of 15th May 2019(1st Jestha, 2076). All bids must be accompanied by a Bid Security as specified in notice with validity period for 30 days beyond the validity period of the bid in accordance with clause 19 of ITB. Bids received after this deadline will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend in person at the Office of Bahradashi Rural Municipality, Chakchaki, Jhapa immediately after the submission deadline at 13:00 Noon 15th May 2019(1st Jestha, 2076).
7. Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
8. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Other Related rules and regulation are as per Public Procurement Act – 2063 and Public Procurement Regulation – 2064.
11. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
