Bahradashi Rural Municipality invites electronic bids from eligible bidders for the **Procurement, Supply and Delivery of Pre-stressed concrete (PSC) pole, ASCR Conductor wire & Miscellaneous Electrical Items with Installation, Stringing & Fittings** under National Competitive Bidding procedures.

Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below upon payment of a non-refundable fee of Nrs 3000.00 before 17.00 Hrs of 6th Sep, 2019 (20th Bhadra, 2076 and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 12.00 Hrs. of 7th Sep 2019(21st Bhadra, 2076). All bids must be accompanied by a Bid Security as specified in notice with validity period for 30 days beyond the validity period of the bid in accordance with clause 19 of ITB. Bids received after this deadline will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend in person at the Office of Bahradashi Rural Municipality, Chakchaki, Jhapa immediately after the submission deadline at 13:00 Noon of 7th Sep 2019(21st Bhadra, 2076).
5. Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
6. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Other Related rules and regulation are as per Public Procurement Act – 2063 and Public Procurement Regulation – 2064.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
